Mayor Tate asked the council for a motion to add fireman applicant Kenneth Womack to the agenda. A motion by councilmember Cash and seconded by Councilmember Wells to add Kenneth Womack to the agenda. Motion passed (6/0)

A motion by Councilmember Hutcheson and seconded by Councilmember Dunigan to approve the minutes of the last regular council meeting held September 19, 2022. Motion passed (6/0)

Mayor Tate discussed the financial statements and liabilities of the City.
