A regular council meeting of the Lake City Council was brought to order at 5:30 pm by the honorable Mayor Cameron Tate.

The meeting was opened with a prayer and the Pledge of Allegiance.

The roll having been called and the following councilmembers answered to their names: BRENDA HUTCHESON, KATE WELLS, TOMMY EAKINS, HARMONY CASH, JAKE EMERY, DANNY DUNIGAN. The meeting continued with the above members and the City Clerk Lisa Sitz present. (6/0).

A motion was made by Councilmember Hutcheson and seconded by Councilmember Wells to approve the minutes of the regular council meeting held August 15, 2022. Motion passed (6/0). Mayor Tate asked the council for a motion to add to the agenda the AT &T tower lease and Riverbend Park lift station. A motion by Councilmember Dunigan and seconded by Councilmember Cash to add AT & T tower lease and Riverbend Park lift station to the agenda. Motion passed (6/0).

The Water/Sewer Audit for the year ending May 31, 2022, is completed with no findings. A motion by Councilmember Dunigan and seconded by Councilmember Hutcheson to accept the water/sewer audit FYE May 31, 2022. Motion passed (6/0).

Clayton Burnside presented to the Council the progress report to his property on Cottonwood.

Mayor Tate discussed with the council about giving Barry Hale (builder) a variance to the last row of lots in the Bowman Addition to go from 9000 sq. ft. to 8000 sq. ft. A motion by Councilmember Hutcheson and seconded by Councilmember Cash to grant the variance to Barry Hale. Motion passed (6/0).

Mayor Tate gave an update on the property at 605 Maumelle.

A motion by Councilmember Hutcheson and seconded by Councilmember Wells to have Mayor Tate contact Arlon Woodruff about drawing up a 10-foot easement to relinquish the property of Prairie Street between Park and Mead St. Motion passed (6/0).

Mayor Tate talked with Council about the location of the Dog Park. After discussion, a motion was made by Councilmember Hutcheson and seconded by Councilmember Emery to set a location for the dog park to be at the Old School Property by the new water tower. Motion passed (6/0).

A motion by Councilmember Hutcheson and seconded by Councilmember Cash to give Mayor Tate the authority to remove Robert Lowery from the Planning and Zoning Committee. Motion passed (6/0).

Diane Crews put a lot of work into getting the city Splash Pad. Mayor Tate discussed re-naming the splash pad and talked with family members about a name honoring Diane. A motion by councilmember Emery and seconded by Councilmember Wells to re-name it "Diane Crews Memorial Splashpad". Motion passed (6/0).

A motion by Councilmember Hutcheson and seconded by Councilmember Wells to set the date for the fall citywide yard sale to be October 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, 2022. Motion passed (6/0).

Halloween day for the city will be October 31, 2022.

Mayor Tate discussed with the council the offer from Harmoni Towers (AT &T tower lease) to the city to buy out the lease. The offer was \$73,000. A motion by Councilmember Dunigan and seconded by Councilmember Hutcheson to have Mayor Tate make a counteroffer of \$100,000.00 to Harmoni Towers with the right to re-negotiate to \$90,000.00. Motion passed (6/0).

Mayor Tate asks the Council about doing away with the lift station at Riverbend Park and going with an above ground pump inside a framed up wood building. After discussion, a motion by Councilmember Dunigan and seconded by Councilmember Wells to approve the installation of an above ground pump inside a framed-up wood building. Motion passed (6/0).
